# 20. INSTALLATION OF E.ON SIGFOX BASE STATION

On 22 April 2024, the Council considered a report recommending the installation of a signal mast on the Younghayes Centre to enable automatic meter readings to be transmitted to E.ON and an associated wayleave agreement. The Council:

- considered the offered indemnity cover as low in cases of e.g. damage to the building during the installation process;
- expressed concerns regarding the proposed connection to the Council's internet network;
- expressed concerns regarding the assumed energy consumption into the mediumterm future and its relation to the proposed rental payments.

On the basis of these concerns, the Council rejected the proposal to install a signal mast on the Younghayes Centre to enable automatic meter readings to be transmitted to E.ON (ref. minute 24/56).

#### 21. UNAUTHORISED ENCAMPMENTS
